LOCATION

Vesey House is excellently located on Sutton Coldfield High Street within the heart of the commercial area of the town centre. Comprehensive local facilities are all close by including the Gracechurch Centre, Sutton Coldfield Railway Station providing regular train services to Birmingham City Centre and Lichfield and the town is well placed for access to the Midland motorway network including the M6, M42 and M6 Toll.

The historic property comprises two floors above the ground floor retail shops offers outstanding character with modern accommodation. The ground floor has three staircases, two of which serve the whole accommodation and the one to the rear gives access to the principle office reception on the first floor. Each floor has three substantial offices to the front (including oak panelled meeting room on the first floor), two good sized rooms to the rear and further office accommodation together with WCs and kitchen. To the rear is a large car park accessed from Reddicroft. Four spaces within the car park are allocated to the shops and the remaining car park is for the use of the offices.
